If no refusal hearing is requested, revocation period begins 30 days after the date of refusal. If a hearing is requested, revocation begins 30 days after the date of refusal or immediately upon a final determination that the refusal was improper, whichever is later. (343.305(10)(a))

ALCOHOL ASSESSMENT AND DRIVER SAFETY PLAN

Court Shall Order:

• Community service for defendant unable to pay the fine (346.65(2g)(ag))

Court May Order:

- Safety plan to include the effect on victim or victim's family
- Community service work that demonstrates adverse effects of substance abuse or OWI to reduce the amount of forfeiture or fine (346.65(2g)(a)) Site visit that demonstrates the effects of substance abuse (346.65(2i))
- Reduction of the forfeiture/fine and payment of the difference toward the cost of the alcohol assessment and driver safety plan (346.65(2e))
- Restitution (346.65(2r)(a))

Note:

Ignition interlock (IID) restriction does not apply to first offense until July 2010, and then only if the PAC is equal to or greater than .15.
